

## POISSANT NOTARIAL RECORD INDEX 1694 to 1830

I have done a rough translation of these records from French to English using the GOOGLE translator and followed up with many Finds and Replaces. GOOGLE does some very literal translations, even on the Given and Surnames. Be aware of errors, especially in the area of pronouns and adjectives. The misspelling of Given and Surnames has been kept as the Notary's entered them.
